Program

Welcome by the president Roman Czaja and thanks to the local organizers (Prof. Noga, Dr. Ogorek). The Conference is very well organized and it is a great honor for the Commission to be in Cracow. It is a pleasure to reassemble in this wonderful conference place.

(1) **New Members** for Romania: Dan Dumitru Iacob (Sibiu), for Hungary (replacement of late György Szekely) Erika Szivos (Budapest) and Ireland (replacement of retired Howard Clarke) Michel Petterton. All new members were accepted by the general assembly unanimously. The General Assembly accepted the resignation of Howard Clarke, he was unanimously accepted as an honorary member.

(2) **The next annual Conference** will take place in Salzburg (2018 September 19–21) and will deal with cultural functions of cities. This Conference will be organized by the Municipal Archive of Salzburg (Dr. Peter Kramml), and the "Österreichischer Arbeitskreis für Stadtgeschichtsforschung" (organizer: Ferdinand Opll and Martin Scheutz). We will have half a day for the Town Atlas Group at the beginning of the meeting (September 19, afternoon). The next Conference will be (in the present state of planning): in Budapest 2019 (organizer: Katalin Szende), in Marburg on Town Atlases 2020 (organizer: Ursula Braasch-Schwersmann). The General Assembly will take place 2020 in Marburg. In Poznan we will organize a half day-section of our Commission.

(3) The new **Statutes of the Commission** have been discussed at the boardmeeting in Bologna (2015) and were presented at the General Assembly in Kiel 2016. The new statutes were accepted unanimously.

(4) **A possible new four year programme of our Commission** (starting 2021) was presented by Martina Stercken (Zurich) – you find the proposal enclosed. We should discuss the suggested programme in Salzburg 2018. All member, who have other proposals, are kindly asked to submit them as soon as possible (**at the latest by 2018 June 30**), the latest before the next meeting of the commission.

(5) **Renewal of membership:** The membership of Marc Boone (2002), Hubert Houben (2002), Magda Pinheiro (2007), Robert Simunek (2012), Francisco José Aranda Pérez (2012), Lorina Repina (1997), Martina Stercken (2002) were prolonged by the General Assembly. President Czaja will send a letter to Lorina Repina in order to get proposals for a new Russian member who works on the history of Russian towns.

Due to his workload Alexandr Kamenskii (2002) will not continue his work for the Commission. The president expresses his gratitude to Prof. Kamenskii.

The membership of Jarosław Miller (2012) was suspended by General Assembly because he did not answer the letters of president Czaja concerning his membership, and he has never appeared at the annual conferences.

(6) **New Member of the Board:** Due to her workload Magda Pinheiro had to decide not to continue her work for the board. President Czaja expresses his gratitude for the work Magda has done for the Commission. Irena Benyovsky Latin (Zagreb) will replace Magda Pinheiro, which was accepted by the General Assembly unanimously.

(7) **New web presence of the Commission:** Francesca Bocchi (Bologna) did a lot of work for improving the homepage of the Commission. The visibility of the Commission depends strongly on the web presence. The new web design will cost 1.170 Euro for basic work as a one-off-payment and 450 Euro as an annual payment. The president thanks Francesca Bocchi for all her efforts to improve the home page! For a long time Francesca Bocchi is Consultant of the commission's homepage.

(8) **Proposal to CISH for next Conference of CISH in Poznan 2020:** Unfortunately the proposals of the Commission for Poznan were not accepted. They have been interpreted as too "European" by CISH. The CIHV will be present in Poznan with a section which will outline the actual four-year-program of the commission (Functionalities of Cities) in a small section (four papers and a summary). Here a couple of people agreed that it would be good, not to present the recent work of the commission but to organize a section that follows the main lines of the conferences topic. The decision on this case should be made in Salzburg.

(9) **Other topics:** Publication of Conference papers: The conferences of Lisbon (2013) and Clermont-Ferrand (2014) are in print now and will be published in the series of "Städteforschung" (Institut für vergleichende Städtegeschichte, Munster, editors Michel Pauly/Martin Scheutz). The papers of the conference of Zurich (2015, editor Martina Stercken) were sent to the publisher (Chronos, Zurich) recently. The papers of the Kiel Conference (2016, editors: Gerhard Fouquet, Ferdinand Opll, Sven Rabeler, Martin Scheutz) will be edited by the end of February 2018 and should be printed till summer 2018.

The president thanks everyone for the numerous attendance in Cracow and look forward to the meeting in Salzburg.

MINUTES OF THE ANNUAL MEETING OF THE ATLAS WORKING GROUP (AWG)

Venue: Pedagogical University of Cracow (ul. Podchorążych 2, Cracow)

1. **Welcome and Introduction** (Ferdinand Opll in the names of Anngret Simms and Katalin Szende):

A retrospect of the evolution of the Historic Towns Atlas-project from the 1950's and 1960's onward makes clear its importance and success as one of the biggest international projects on urban historical research. At the present time 19 countries are represented and the number of towns included has already passed the number of 500. The great challenge of today is bound to the digital evolution and the step from using the World Wide Web as a source of information towards new possibilities of interactive presentations and availabilities of our work. There is a lot of activities going on since 2012 when Katalin Szende organised a first workshop dedicated to these new challenges at the CEU in Budapest (see n. 3 of the minutes). Nevertheless, such big projects do include many possibilities of divergence: deviations from the recommended scales of the maps, failures to include certain maps, differences of commentaries on the historical evolution of towns, the production of historical gazetteers and/or the different methods of the production of maps showing the growth-phases of a town. However, we should pay respect to the different situations that national Atlas-teams find themselves in but also try and keep up our willingness to compromise. We should make use of what we have and not lament too much about what we do not have. We should be conscious of the richness of material which has been brought together and which will increase as our project extends into the future.

2. **Change of conveners of the AWG:**

It was in 1993 when the late president of our Commission, Adriaan Verhulst, under the impression of the rise of new Towns Atlas-projects in East-European countries after the fall of the Berlin Wall suggested the creation of an AWG within the ICHT. It was Anngret Simms since the start of the 1980's dedicated collaborator of the Irish Historic Towns Atlas who took the chance and brought this group into being prompting Ferdinand Opll to help her in organising this new platform. In 2010 Katalin Szende, our ever so active Hungarian member and founder of the Hungarian Historic Towns Atlas, joined Anngret and myself as the third convener of the AWG. After almost a quarter of a century Anngret who was always full of energy and in fact the real motor of the group has decided to retreat from this function committing an incredibly worthwhile intellectual heritage to all of us. This situation demanded the appointment of a successor to Anngret as convener of our AWG and Katalin and Ferdinand were very happy to get the approval of Keith Lilley to step in. The participants of the Cracow-meeting gave their consent by acclamation.

3. Report on the COST-Project and on the Workshop “GIS-based cartography” (Daniel Stracke):

Since first considerations in 2012 (Workshop in Budapest on the initiative of Katalin Szende) efforts are in process within the AWG to coordinate the digital activities of the Towns Atlas-projects and publications on Internet. Repeatedly Keith Lilley and Sarah Gearty, at last Daniel Stracke have applied for an EU-funding of a network of researchers (Meetings and Conferences for scientific exchange and the establishment of standards) within the COST-Programme (Cooperation for Science and Technology). The last application supported by 32 scholars, members of Towns Atlas-projects as well as geoscientists and computer scientists, was refused in July 2017. At the moment discussions are going on between Sarah Gearty, Keith Lilley and Daniel Stracke about a redesigned and reiterated application concerning the establishment of a network of researchers.

From March 22–25, 2017, a workshop on “GIS-based cartography – A change of media or a change of paradigms for Historic Towns Atlases” was organised by Daniel Stracke at the Institute for comparative urban history in Münster (programme, see:

http://www.uni-muenster.de/imperia/md/content/staedtegeschichte/veranstaltungen/weitere_veranstaltung_en/programme_workshop_cartography_march_2017.pdf [22.9.2017]); the report about its results is available on: <http://www.hsozkult.de/conferencereport/id/tagungsberichte-7281> (24.10.2017).

4. Conferences or workshops based on the Atlas project:

- a. **Report by Keith Lilley:** Shared European Heritage: Irish Towns compared with British Towns (part of a 3-year-programme 2016–18); this year's joint seminar was on "Mapping Townscapes" (18–19 May 2017), held at the Royal Irish Academy, Dublin (programme, see: https://www.ria.ie/sites/default/files/ihta-seminar-2017_1.pdf [22.9.2017]). Next year's seminar will be held in May 2018 and focus on the Early-Modern era (organisers: Keith Lilley – Sarah Gearty)
- b. **Report by Sandrine Lavaud:** In 2013 the program “The capital-towns (head-towns) of Aquitaine: historical, cartographic and comparative approaches” was started containing the publication of five new towns in the series of the Atlas Historique de France. Agen has been published recently, and the editorial calendar, defined with the publishing company Ausonius is focusing on the production of the atlases of Pau, Mont-de-Marsan, Périgueux and Bayonne until next year. As the Aquitaine Regional Council as the main financier has given an additional year to this programme the different teams under the directorship of Sandrine and Ezéchiél Jean-Courret will finalise the whole series in July 2018 with the colloquium "Passerelles urbaines", a conference on the utilisation of the atlases in the context of research on urbanism.
- c. **Report by Katalin Szende:** A Workshop on comparative aspects of urban topography based on the Historic Towns Atlases was organised in cooperation between the VISCOM project (see: <https://www.oeaw.ac.at/imafo/arbeitsgruppen/fruehmittelalter/projekte-historische-identitaetsforschung/viscom/> [22.10.2017]) and the Hungarian Atlas team (Judit Majorossy, Magdolna Szilágyi and Katalin Szende) in Vienna from 4–6 October 2017 (programme, see: https://viscom.ac.at/fileadmin/user_upload/Folder-TOWNS_as_Living_Spaces.pdf [22.10.2017]).

5. New Publications or publications in progress, associated with the Historic Towns Atlas project:

Report by Howard B. Clarke: After the publication of “Reading the maps: a guide to the Irish Historic Towns Atlas, eds. Howard B. Clarke – Jacinta Prunty (Dublin 2011)”

and “Maps & Texts. Exploring the Irish Historic Towns Atlas, eds. Sarah Gearty – Howard B. Clarke (Dublin 2013)” the next publication of the Irish Historic Towns Atlas (IHTA) team will be published in spring 2018 under the title: “ Maps and texts as sources: Evaluating the Irish Historic Towns Atlas, eds. Howard B. Clarke – Sarah Gearty”. It will also contain the proceedings from the annual IHTA seminar series ‘Maps and texts: using the Irish Historic Towns Atlas’ that took place in the Royal Irish Academy from 2012 to 2014.

6. **Report on national Atlas publications 2016/2017** (This Report based on the information provided by the national Atlas-teams was sent by Mail to all members of the Commission and of its Atlas Working Group on September 6, 2017).

Report by Marjatta Hietala: The next volume of the Scandinavian Atlas of Historic Towns, New Series, dedicated to Finland will be dedicated to Wyborg (Russian Выборг). This town belonged to Russia from the early 18th century onwards and became part of independent Finland in 1917. After the Winter War (1939/40) it became part of the Soviet Union (today: Russia). The Towns Atlas-volume will be based on a cooperation between Finish and Russian specialists.

Report by Myron Kapral: The Ukrainian Atlas of Historic Towns started in 2014 with the publication of the Atlas on Lemberg/Lviv. This year (2017) the second volume was published containing the small town of Zhovkva north of Lemberg/Lviv. The translation of the texts into English were supported by Anngret Simms.

Report by Michel Pauly and Martin Uhrmacher: The Luxembourg Atlas of Historic Towns has already been started with the city of Luxembourg. It will not be printed but the publication will be available on Internet. Due to the suggestions to include a number of maps after the cadastral map up to the present time (see: [http://www.historiaurbium.org/english/Opll Atlases%20beyond%201900 ENGLISH SIMMS 24112012.pdf](http://www.historiaurbium.org/english/Opll%20Atlases%20beyond%201900%20ENGLISH%20SIMMS%2024112012.pdf) [22.10.2017]) this Atlas has been started from modern maps aiming back to the cadastral map. In doing so the Atlas-team has encountered great difficulties because of data-protection concerning the names of proprietors of houses and is very much interested to get to know about comparable difficulties of other Towns Atlas-projects.

7. Any other business:

- a. Anngret Simms reports about the success of the sale of the book “Lords and Towns in Medieval Europe. The European Historic Towns Atlas Project (Ashgate, Fanham – Burlington 2015)”, edited by her together with Howard B. Clarke and the project of the publishing company Routledge (part of the Taylor & Francis-Group) which took over Ashgate in 2016 to publish the book in a paperback-version.

URBAN ORDER
Proposal for a next Four-year-programme of the ICHT

The premise of this proposal is to establish the ICHT as a leading intellectual force in the historical study of urbanism. This requires not just a thematic issue that speaks universally and internationally to urban historians, archaeologists and geographers but also one which engages with contemporary social and cultural challenges and issues.

To this end, 'Urban Order' has particular potency as a topic. In times of political fissure and social fragility the idea of order has major resonance. This is reflected by a considerable number of recent publications from different disciplines. The power of order as a concept of political theory has been analysed anew, particularly through concepts of 'spatial order'. The 'borders', and the criteria of social order, have been considered, particularly with regard to the cultural politics but also for historians, 'order' is a means of exploring historical practices, including ordering through social distinction. Here time-specific conceptual designs of order, threatened orders, as well as processes, scenarios and perceptions of disintegration through 'disorder', are all subjects relevant to current historical discourse.

Many of these approaches include research on European towns and cities. However, more systematic analyses of towns as a symbol of order, of the range of different (social, economic, constitutional, urbanistic etc.) orders, which characterise towns, and of towns as a projection screen for ideas of order have not been considered yet. The next four-year-programme of the ICHT could help to structure the discussion on urban order. Rather than to focus simply on structures of order, a long term and comparative perspective could aim to look into the processes of forming order and to study the manifold forms in which ideas of urban order are developed and shaped.

The huge field of possible aspects could be concentrated in four fields, which stress partially moments of reflection on urban order and partially emphasise action-related situations dealing with disorder in the order:

- (1) Discourses on the peculiarities of urban order** (chronicles, treatises, ecclesiastical order, urban administration, mass-media, literature, debates on town-planning etc.)
- (2) Means of mediating urban order** (town-planning, writing, images, maps, seals, rituals, urban organizations, new media etc.)
- (3) Crisis of urban order** (guild-struggles, uproars, destructions by natural catastrophes or wars, population explosions, out-migrations, waves of refugees etc.)
- (4) Protagonists of the change of order** (leading-groups, gang-leaders, countrymen, demonstrators, youth-culture, migrants etc.)

ECONOMIC FUNCTIONS OF URBAN SPACES FROM THE MIDDLE AGES TO THE PRESENT

Block 1: Spaces of Commerce – from open markets to shopping malls

The first block of the conference discusses the development of various spaces as nodal points for the exchange of commodities that took place in cities and towns from the Early Middle Ages onwards. We invite papers to engage with the following questions:

- How did commercial activities shape the places of commerce and how did the available space influence the range of commercial activities pursued?
- How did the commercial infrastructure become differentiated according to the types of commodities and the frequency of exchange (weekly and daily markets, and annual fairs, permanent storage and shopping facilities, etc.)?
- How and why did local authorities regulate the spatial aspects of commodity exchange? How were potential conflicts between local and broader interests handled?
- How did commercial spaces – such as markets, shopping streets, department stores, or malls - influence social interactions, urban lifestyles, and mentalities? How did they generate new patterns of consumption?

Block 2: Spaces of Production – from workshops to factories

The second block examines places within urban space devoted to the production of industrial commodities as well as mining and minting. The main questions to be addressed are:

- Where do workshops, manufacturing plants and factories appear in urban space and how do they transform its use? How does industrial activity foster or limit urban development?
- Which factors determine the settling of various industrial functions and how do these change over time (the availability of raw materials, workforce, markets)? How can former industrial areas be reincorporated into lived urban space?
- What kinds of activities and enterprises were promoted or pursued by cities as communities? How do state administration and private entrepreneurs interact with or limit local autonomy in favour of economic interests?

Block 3: Spaces of Action – from local to global

The third block will address dynamic aspects of the spatiality of trade and production within towns, their interconnectedness, and the networked character of urban space through traffic and transport on land, water, and air. Papers should address the following issues:

- How did the catchment area of towns change over time depending on means and infrastructure of transport (roads, harbours, fords, bridges, airports, stations)?
- Which roles did town and country relations play in the spatial distribution of urban economic functions?
- What steps did city authorities take to capitalize on transport dynamics? How do conflicts of interests between various groups or individuals play out in urban space?

We invite local and regional case studies as well as broader, theoretically focussed papers on these topics. Papers based on the systematic use of the Historic Town Atlas series are particularly welcome.

Block 1: Räume des Handels – von offenen Märkten zu Shopping Malls

Der erste Block der Konferenz befasst sich mit der Entwicklung verschiedener Stadträume als Brennpunkte für den Warenaustausch, der in Städten seit dem Mittelalter stattfand. Wir ersuchen um Beiträge, die sich mit den folgenden Fragen auseinandersetzen:

- Wie formten Handelsaktivitäten die Schauplätze des Handels und wie beeinflusste der verfügbare Raum deren Umfang?
- In welcher Weise kam es in Entsprechung zu den Warenarten und der Häufigkeit des Handels (wöchentlicher und täglicher Markt, jährliche Messen, ständige Lager und Verkaufseinrichtungen etc.) zu einer Differenzierung der kommerziellen Infrastruktur?

Block 2: Räume der Produktion – von Werkstätten bis hin zu Fabriken

Der zweite Block untersucht Räume, die im städtischen Kontext der Güterproduktion von Industriewaren über den Bergbau bis hin zur Münzprägung dienten. Die wesentlichen hier zu behandelnden Fragestellungen sind:

- Wo begegnen im städtischen Raum Werkstätten, Produktionsanlagen und Fabriken und wie transformieren sie dessen Nutzung? In welcher Form begünstigen oder behindern gewerbliche Aktivitäten die städtische Entwicklung?
- Welche Faktoren bestimmen über die Ansiedlung verschiedener industrieller Funktionen und wie verändern sich diese im zeitlichen Verlauf (Verfügbarkeit von Rohmaterialien, Arbeitskräften, Märkten)? Wie können frühere Industriezonen in den gelebten städtischen Raum reintegriert werden?

Block 3: Handlungsräume – vom Lokalen zum Globalen

Der dritte Block soll dynamische Aspekte der Räumlichkeit von Handel und Produktion in Städten ansprechen, ihre Vernetzung miteinander und den Netzwerkcharakter städtischen Raumes im Kontext von Verkehr und Transport über Land, auf dem Wasser und in der Luft. Die Beiträge sollten folgende Themen behandeln:

- Wie veränderte sich der Einzugsbereich von Städten in Abhängigkeit von den verfügbaren Mitteln und der Infrastruktur der Transportmöglichkeiten (Straßen, Häfen, Furten, Brücken, Bahnhöfe, Flughäfen) über die Zeiten?

Bloc 1 : Espaces du commerce – du marché ouvert à la grande surface

Le premier bloc de la conférence est consacré au développement de certains espaces urbains où se cristallise l'échange commercial qui avait lieu dans les villes depuis le moyen âge. Nous attendons des contributions qui traiteront des questions suivantes :

- Comment les activités commerciales modelaient-elles les lieux du commerce et comment l'espace disponible influençait-il leur volume ?
- De quelle manière le type de marchandises et la fréquence du commerce (marché quotidien et hebdomadaire, foires annuelles, entrepôts et magasins permanents etc.) ont-ils contribué à une différenciation de l'infrastructure commerciale ?
- Comment et pourquoi les autorités locales ont-elles réglementé les conditions spatiales de l'échange commercial ? Comment ont-elles réagi à des conflits potentiels entre intérêts locaux et supérieurs ?
- De quelle manière les espaces destinés à l'économie – marchés, rues commerçantes, grands magasins, centres commerciaux e. a. – ont-ils influencé les interactions sociales, les styles de vie, les mentalités ? Comment ont-ils généré de nouveaux modèles de consommation ?

Bloc 2 : Espaces de production – de l'atelier à la fabrique

Le deuxième bloc analyse des espaces qui servaient, dans le contexte urbain, à la production de biens, de marchandises industrielles au monnayage en passant par l'exploitation minière. Les questions principales à traiter sont :

- Où rencontre-t-on dans l'espace urbain des ateliers, des installations industrielles, des fabriques et comment transforment-ils son utilisation ? Sous quelle forme les activités industrielles favorisent ou empêchent-elles le développement urbain ?
- Quels facteurs sont décisifs pour l'implantation de certaines fonctions industrielles et comment changent-ils au fil du temps (disponibilité de matières premières, de main d'œuvre, de marchés) ? Comment d'anciennes zones industrielles peuvent-elles être réintégrées dans l'espace urbain vivant ?
- Quels genres d'activités et d'entreprises artisanales ou industrielles sont promues par la municipalité, voire exercées par elle-même ? De quelle manière y a-t-il de la part de l'administration de l'Etat et d'entrepreneurs privés des interactions avec, voire des restrictions de l'autonomie locale en faveur d'intérêts économiques ?

Bloc 3 : Espaces d'action – du local au global

Le troisième bloc doit aborder les aspects dynamiques de l'espace urbain du commerce et de la production, leur interconnexion et l'insertion de l'espace urbain dans des réseaux dans le cadre de la circulation et des transports par terre, par eau et par air. Les communications devraient traiter des thèmes suivants :

- Comment s'est transformée la zone de rayonnement des villes en relation avec les moyens disponibles et l'infrastructure des transports (routes, ports, gués, ponts, gares, aéroports) à travers les époques ?
- Quel rôle a joué la relation ville-campagne pour la répartition des fonctions économiques urbaines ?
- Quelles mesures ont pris les autorités urbaines pour tirer profit des dynamiques du transport ?
- Quelles répercussions avaient des conflits d'intérêts de différents groupes ou individus sur l'espace urbain ?

Nous attendons aussi bien des études de cas locales et régionales que des contributions à focus plus large et d'une approche plus théorique. Des communications qui s'appuient sur l'utilisation systématique des atlas historiques des villes sont particulièrement bienvenues.

STATUTES
(Cracow, 2017 September 14)

1. Aims and Activities

The International Commission for the History of Towns aims to establish contacts and facilitate the coordination of research between specialists in all branches of the history of towns.

To achieve these aims, the Commission:

- organises within the framework of the scientific part of its General Assemblies colloquia dedicated to a particular theme;
- publishes an information bulletin ("Nouvelles"/ "Newletters") on the homepage of the Commission;
- coordinates the work of the European Historic Town Atlas,
- and supports all other kinds of study and research in urban history.

2. Status

The Commission constitutes an international body affiliated to the International Committee of Historical Sciences in accordance with their regulations.

3. Members

3.1 Categories

The Commission is composed of three categories of members:

(a) Active national members, confirmed by the General Assembly, after evaluation and approval of the candidates by the Bureau. These will be a maximum of about 70 full national members;

(b) Full intercontinental members, confirmed by the General Assembly.

(c) Honorary members proposed by the national members and confirmed by the General Assembly after deliberation by the Bureau

3.2 Mandate

The mandate of full members, national and intercontinental, will last for 5 years with the possibility of renewals on the condition of active membership within the Commission.

3.3 Voting rights

Only full members may vote.

4. Working groups

The members of the Atlas Working group consist of active members of national atlas teams and of full and honorary members of the Commission for the History of Towns. The Atlas Working group has own sessions in addition to the General Assembly of the Commission.

Other working groups may be installed by the General Assembly to carry out tasks enumerated in article 1.

5. The Bureau

5.1 The Bureau consists of a president, 2 vice-presidents, a secretary and a deputy-secretary, a treasurer and a deputy-treasurer and of not more than 5 full Commission members. Bureau members are elected every 5 years by the General Assembly following the International Congress of Historical Sciences. Their mandate is renewable.

5.2 The election of the president and of the two vice-presidents will take place on one ballot before that of other members of the Bureau who will be elected by a single vote from a list presented by the newly-elected president and vice-presidents.

Elections are made by an absolute majority of votes from the full members present. A quorum is fixed at 50% of full members. If members are not able to attend the general assembly they have to send a replacement; each member can present only one replacement of an absent member.

5.3 The Bureau will meet at least once a year. The meeting could take place as a virtual conference.

5.4 The Bureau is concerned with the workings of the Commission, with financial matters, with preparations for the General Assembly, with relations with national and international organisations.

6. The General Assembly

The General Assembly is the regular meeting of the three categories of members of the Commission.

6.1 There will be at least one general assembly every year.

6.2 The choice and preparation of an Urban History theme for the International Congress of Historical Sciences, as well as the discussion of those theme and other scientific research based on work done by members of the Commission and/or external experts is the prime concern of the General Assembly.

6.3 The General Assembly is in charge of statutory business, the proposals of the Bureau concerning the election and re-elections of members, elects the Bureau, confirms honorary members and receives the reports of Bureau meetings and the annual report of the treasurer.

6.4 The General Assembly may set up from its membership working groups to carry out certain of the Commission's tasks, notably those enumerated above under article 1.

7. Finances

7.1 At the time of a General Assembly or a meeting of the Bureau, each member will be responsible for their own travel and accommodation costs, unless the host country undertakes to pay them in whole or in part. In special cases the Commission will try to facilitate the attendance of members at the General Assembly.

7.2 Each member of the Commission pays an individual subscription, which is fixed by the General Assembly.

7.3 All active members of the Commission who omit to pay their subscription for three successive years without good reason, will be considered as having resigned. The honorary members may decide to keep on paying the equivalent of the members' subscription.

(These new statutes have been worked by the Bureau at Bologna in February 2016).

Dan Dumitru Iacob is senior researcher at the Institute of Social-Sciences and Humanities in Sibiu (branch of Romanian Academy), in the Department of Urban History. Its doctoral thesis, entitled *The Elite of the Romanian Principalities in the Middle of the 19th Century.
