## WORKSHOP ON THE USE OF GIS AND HISTORICAL TOWNS ATLASES

Dublin, 2018 May 16–17

On 16-17 May 2018 the Royal Irish Academy hosted a workshop co-organised by Sarah Gearty (Royal Irish Academy, Dublin), Keith Lilley (Queen's University, Belfast), and Daniel Stracke (Institute for Comparative Urban History – IStG, Münster). It was on the most important feature of the Historic Towns Atlases, the 1:2.500 base map each atlas in the European scheme features. It is the main map and primary source for analysis in urban morphological studies. The event was held to follow up on the more general meeting of the previous year hosted by the IStG in Münster reiterating the use of Geographic Information Systems (GIS) in the production of Historic Towns Atlases. Bringing together thirteen colleagues from Ireland, the United Kingdom, Hungary, Poland, and Germany, the group was small enough for a hands-on approach to the comparison of working methods.

Before the digital practices were explored, however, print copies of the 1:2.500 map were laid out on the table. Each atlas team reported on the sources they use to prepare the maps as well as their cartographic properties, elements, and styles. Drawing on further examples from the IStG collection, Daniel Stracke identified four basic approaches to realising this map which the discussion showed to be rooted in the individual traditions of the projects as much as in the historic sources used to produce them. The differences the large-scale maps display across the European Historic Towns Atlas are widely held to be a problem for comparative morphological studies.

On the following day, the Irish atlas team presented their map production process in detail with the other participants commenting on commonalities and alternative methods. Regarding the crucial steps of geo-referencing and vectorisation, considerable progress was made towards Best Practice solutions. Perhaps the most important result is that many of the differences in visualisation and map content are largely irrelevant on a data level. Thus, there are fewer inhibitions to the comparative use of the geodata than of the print maps which is beneficial to conducting urban studies based on GIS.

The workshop organisers are planning to submit the findings in detail in an article for the periodical *Urban History* to ensure their maximum visibility. They would like to thank the participants, Justin Colson, Frank Cullen, Tobias Kniep, Jennifer Moore, Rachel Murphy, Melanie Müller-Bering, Agnieszka Pilarska, Jacinta Prunty, and Madgolna Szilágyi for coming to Dublin and offering their first-hand insights. Thanks are also due to the Royal Irish Academy for hosting the event and to Anngret Simms for her introductory remarks and contribution to the discussion.

## URBAN ORDER

The premise of this proposal is to establish the ICHT as a leading intellectual force in the historical study of urbanism. This requires not just a thematic issue that speaks universally and internationally to urban historians, archaeologists and geographers but also one which engages with contemporary social and cultural challenges and issues.

To this end, 'Urban Order' has particular potency as a topic. In times of political fissure and social fragility the idea of order has major resonance. This is reflected by a considerable number of recent publications from different disciplines. The power of order as a concept of political theory has been analysed anew, particularly through concepts of 'spatial order'. The 'borders', and the criteria of social order, have been considered, particularly with regard to the cultural politics but also for historians, 'order' is a means of exploring historical practices, including ordering through social distinction. Here time-specific conceptual designs of order, threatened orders, as well as processes, scenarios and perceptions of disintegration through 'disorder', are all subjects relevant to current historical discourse.

Many of these approaches include research on European towns and cities. However, more systematic analyses of towns as a symbol of order, of the range of different (social, economic, constitutional, urbanistic etc.) orders, which characterise towns, and of towns as a projection screen for ideas of order have not been considered yet. The next four-year-program of the ICHT could help to structure the discussion on urban order. Rather than to focus simply on structures of order, a long term and comparative perspective could aim to look into the processes of forming order and to study the manifold forms in which ideas of urban order are developed and shaped.

The huge field of possible aspects could be concentrated in four fields, which stress partially moments of reflection on urban order and partially emphasise action-related situations dealing with disorder in the order:

- (1) Discourses on the peculiarities of urban order** (chronicles, treatises, ecclesiastical order, urban administration, mass-media, literature, debates on town-planning etc.)
- (2) Means of mediating urban order** (town-planning, writing, images, maps, seals, rituals, urban organizations, new media etc.)
- (3) Crisis of urban order** (guild-struggles, uproars, destructions by natural catastrophes or wars, population explosions, out-migrations, waves of refugees etc.)
- (4) Protagonists of the change of order** (leading-groups, gang-leaders, countrymen, demonstrators, youth-culture, migrants etc.)

### NOTICE NÉCROLOGIQUE : JEAN-PIERRE KINTZ (1932–2008)

Membre honoraire de notre commission depuis de longues années, notre collègue Jean-Pierre Kintz, professeur honoraire de l'Université de Strasbourg, né en avril 1932 à Illkirch-Grafenstaden, à une petite dizaine de km au sud de la métropole alsacienne, est décédé en février 2018, à Strasbourg, à l'âge de 85 ans.

Jean-Pierre Georges Joseph Kintz a accompli son cursus d'études secondaires et supérieures dans la grande ville alsacienne. Son mémoire de Diplôme d'Études Supérieures portait sur la presse politique à Strasbourg dans la deuxième moitié du XIXe siècle. Il fut reçu à l'agrégation d'histoire en 1962 et enseigna l'histoire et la géographie au lycée Kléber de Strasbourg (1962-1969), puis devint assistant à l'université. Il y soutient, en 1970, sa thèse doctorale d'histoire intitulée « Journaux politiques et journalistes strasbourgeois sous la Seconde République et jusqu'à la fin du Second Empire » et devient enseignant-chercheur dans cette même université où, remontant vers la première modernité, il présenta, en 1980, sous la direction de Philippe Dollinger, sa thèse d'État, sur « La société strasbourgeoise du milieu du XVIe siècle à la fin de la Guerre de Trente ans (1560-1650). Essai d'histoire démographique et sociale », publiée en 1984. Élu professeur à l'Université de Haute-Alsace à Mulhouse, il y exerça de 1983 à 1991, date à laquelle il rejoignit l'université Strasbourg (Université Marc Bloch). Titulaire de la chaire d'Histoire moderne, il y acheva sa carrière académique en 2000. Son dernier ouvrage, *La conquête de l'Alsace : le triomphe de Louis XIV, diplomate et guerrier*, est paru en 2017.

Spécialiste de l'histoire de l'Alsace, Jean-Pierre Kintz a été, entre 1982 et 2003 le directeur de publication du *Nouveau Dictionnaire de biographie alsacienne*, édité par la Fédération des sociétés d'Histoire et d'Archéologie d'Alsace dont notre collègue, devenu professeur émérite, a assumé la présidence de 2000 à 2008. Il enseignait également au Centre Universitaire d'Enseignement du Journalisme de Strasbourg et avait, pu montrer dès 1987, avec Martin Welke, historien allemand de la presse, comment la maison fondée par l'imprimeur strasbourgeois Johann Carolus (1575–1634) avait publié, en allemand, dès septembre 1605 et jusqu'en 1659, la *Relation aller Fürnemmen und gedenckwürdigen Historien*, ce qui méritait à cette publication, recueillant et relayant des informations venue de l'Europe entière et jusque de Moscovie et de Turquie, le titre de premier hebdomadaire imprimé en Europe.

Jean-Pierre Kintz avait, depuis 1999, le grade de commandeur dans l'ordre ministériel français des Palmes académiques. L'Académie des Sciences morales et politiques l'avait récompensé en 2003 par l'octroi du prix Marcel Flach, décerné pour l'ensemble de son œuvre en démographie historique.

**NACHRUF WILHELM RAUSCH (1927–2019)**

Am 14. Februar 2019 ist Wilhelm Rausch im niederösterreichischen Groß Gerungs, seinem Lebensmittelpunkt seit seiner Pensionierung im Jahr 1987, verstorben. In den unmittelbaren Nachkriegsjahren hatte er in Wien Geographie und Geschichte studiert, von 1951 bis 1953 den Ausbildungskurs am Institut für Österreichische Geschichtsforschung absolviert. Vorübergehend an diesem Institut tätig, trat er 1954 in die Dienste der Linzer Stadtverwaltung, wo er in 33 Jahren Berufstätigkeit das Stadtarchiv leitete und von 1978–1983 als oberster Kulturbeamter der Stadt wirkte. Ein traditionelles Verständnis des Archivarsberufs als Wissenschaftler wie Verwaltungsbeamter zeichnete ihn aus, doch waren es vor allem seine großen Befähigungen zum Organisator, Manager und begnadeten Networker, die sein Wirken bestimmten und prägten. Bereits 1961 konnte er in Linz eine internationale Tagung zur frühen Stadtgeschichte veranstalten und dabei Wissenschaftler aus West und Ost zusammenführen. Auch seine Kontakte zur Commission internationale pour l'histoire des villes (CIHV) gehen in die frühen 1960er Jahre zurück, seine Mitgliedschaft wurde 1968 endgültig fixiert. Ein Jahr später, 1969, gelang es ihm, den Österreichischen Arbeitskreis für Stadtgeschichtsforschung ins Leben zu rufen, Grundlage für eine institutionelle Verankerung der vergleichenden Stadtgeschichte in seinem Heimatland. Als ihm in der Mitte der 1970er Jahre auch noch regelrechte Institutsgründungen gelangen – in Wien in engem Zusammenwirken mit dem Wiener Stadt- und Landesarchiv –, war das Fundament dafür geschaffen, die drei großen Forschungsprojekte der CIHV, Elenchus, Bibliographie und Städteatlas, in Österreich realisieren zu können. Wiewohl die Institute 2011 ein Ende finden sollten, konnten nicht nur alle drei Kommissionsvorhaben umgesetzt werden, sondern es ist zudem gelungen, das gleichfalls von Rausch ins Leben gerufene Periodikum, die Zeitschrift „Pro civitate Austriae“, bis zur Gegenwart – nunmehr in einer Kooperation zwischen Arbeitskreis, Wiener Stadt- und Landesarchiv sowie Verein für Geschichte der Stadt Wien – fortzuführen.

Der von Wilhelm Rausch gegründete „Arbeitskreis“ kann heuer, genau im Jahr seines Ablebens sein 50-jähriges Bestandsjubiläum begehen. Aus den Tagungsaktivitäten dieser Forschungsgemeinschaft, zunächst auf eine chronologische Behandlung städtischer Entwicklungen fokussiert, ab 1988 dann in thematischen Annäherungen fortgeführt, ist eine stattliche Publikationsreihe („Beiträge zur Geschichte der Städte Mitteleuropas“) erwachsen. Zuletzt ist 2018 der 28. Band („Fernweh und Stadt. Tourismus als städtisches Phänomen“) erschienen. Noch zu Ende seiner Berufslaufbahn (1987) konnte Rausch mit der Gründung der Stiftung „Pro civitate Austriae“ die institutionelle wie finanzielle Basis dafür schaffen, dass seither im zweijährigen Turnus ein mit einer durchaus namhaften Summe ausgestatteter Preis für stadthistorische Arbeiten vergeben werden kann.

Seinem so eindrucksvollen Lebenswerk in all seinen Ausprägungen blieb er bis ins hohe Alter aufs engste verbunden, zeigte stetes Interesse für den Fortgang stadthistorischer Forschung, bis zuletzt immer bereit, seine Meinung zu äußern und beizutragen. An den Generalversammlungen der CIHV nahm er lange teil, selbst als er seinen Platz unter deren Mitgliedern 1997 an Jüngere abgegeben hatte und seit damals als Ehrenmitglied fungierte.
