**CRISIS OF URBAN ORDER
ICHT 2022**

Maynooth, Dublin, Derry, Ireland/UK
13-16 September 2022

Overview: Addressing the overall theme of *Urban Order*, the ICHT 2022 programme will take a comparative historical and geographical approach to explore *Crisis in Urban Order*. The themes will encompass a range of crises and their spatial, cultural and material impacts and manifestations on the towns and cities of Europe but with a particular focus on the island of Ireland. 2022 marks the centenary of the Partition of Ireland, and the creation of a border on the island between ‘north’ and ‘south’ that has had profound implications for urban order, with legacies still today for cities across Ireland. Papers will address ‘crisis’ over the medieval, early-modern and modern periods precipitated by natural catastrophes such as disease and environmental change, war and religious and political conflicts, population migrations and movements. The programme will span the island of Ireland, between ‘north’ and ‘south’, by being based in two locations, Dublin/Maynooth and Derry/Londonderry. It builds on an existing collaboration between the Irish Historic Towns Atlas and the British Historic Towns Atlas programmes, and is jointly convened by Maynooth University, Royal Irish Academy and Queen’s University Belfast in the spirit of connecting Ireland north and south in our centenary year.

**THE GENERAL TOPIC OF THE “COMMISSION FOR THE HISTORY OF TOWNS” 2016–2020:
ESSENTIAL FUNCTIONALITIES OF URBAN SPACES THROUGH THE AGES**

During its General Assembly in Lisbon (2013) the Commission had a vivid discussion about its Four-Years-Program (starting with 2016). The goal was to find a topic spanning from the Middle Ages up to the present and in line with actual discussions in the sphere of Urban Historical Research. The proposal made by the authors of this short retrospection at the General Assembly of 2013 was to concentrate on the spatial dimension of towns with a strong focus on essential functionalities of urban spaces through the ages.

In fact, towns are characterised by a great variety of different spaces. Amongst them, the open space which can be used by different people, different age groups, ethnicities, religious groups, institutions and the urban government, the civic body, deserves special attention. These manifold groups – often real pressure groups – can appropriate such an urban space for their own purposes, transform it or restrict access to it.

The different uses of urban space were in the core of the Four-Years-Program of the Commission from 2016 to 2019, and in Lisbon already concepts for four Conferences (political, economic, cultural and social functions of space) were being designed focusing not at least at the possibility to invite not only members of the Commission but also representatives of the fields of the respective Conference-venues.

Based on the great efforts of the colleagues responsible for the local organisation, it was possible to raise the funds for four meetings in four different countries. The series started in Kiel/Germany in 2016 (September 15–16) with the topic “Changing Social Functions of Urban Spaces” organised by Gerhard Fouquet and Sven Rabeler). The year after the Commission met in Cracow/Poland (September 14–16) to discuss “Political Functions of Urban Spaces through the Ages”; at the same time and in the same place the Atlas Working Group of the Commission set up a smaller Conference on “Town Types through the Ages” and both events took place organised by Roman Czaja, Zdzisław Noga and the two authors of these lines. In 2018 Salzburg/Austria (September 19–21) was the place to meet and to continue with the discussion of the topic decided upon in Lisbon five years ago. Due to Salzburg as an internationally most renowned city of culture the topic “Cultural Functions of Urban Spaces through the Ages” was chosen for this Conference organised by Peter Kramml, director of the Salzburg city Archives, together with the two authors of this summary of the Four-Years-Program. The last of the four Conferences took place in Budapest/Hungary in 2019 (September 18–21) where Katalin Szende, Erika Szívós and Boglárka Weisz acted as organisers for the topic “Economic Functions of Urban Spaces from the Middle Ages to the Present”.

The volumes with the contributions of the Conferences 2016–2018 have been published already, the papers of the Budapest-Conference are under press:

The social functions of urban space are illustrated using examples of Jewish communities, hospitals and the courtyard (Centre and Periphery). The thematic field “Top and Bottom” is being developed along the social protest in urban spaces. Inter-

or and exterior spaces are discussed using church spaces, the Reichstag and the environmental history of a city as examples.

The contributions of the Cracow-Conference analyse the importance of Town Halls in Italy, Croatia, the Danube region, the Netherlands and Sweden. A second part of the conference dedicated to Town Atlases focused on Town Types: Residential Towns, Harbour Towns, Fortress Towns, Monastery Towns, Industrial Towns are compared on a European level.

- Katalin SZENDE, Erika Szívós, Boglárka WEISZ (eds.), *Market and Trade* (London 2021, forthcoming): The spaces of the economy in urban areas are widely spread: Markets in Italian Cities, in the Ukraine or in Romania provide good examples. Archaeological excavations illustrate the economic interconnections of cities as early as the early Middle Ages. But it is also possible to take under consideration the orientation of different city quarters by analysing certain economic areas and their changes.

MARIA BOGUCKA (1929–2020)

Professor Maria Bogucka, the great lady of contemporary Polish historiography, passed away on the night of October 27, 2020. For years she did not leave her apartment, but until the very end she diligently followed the events in the world of science and kept publishing articles. Her published research output exceeded 2000 items.

Maria Bogucka was born on June 1, 1929 in Warsaw, and although her life and career as a scientist were associated with the Polish capital, without a doubt the city to which she devoted most attention in her research was Gdańsk and its history in the modern period.

Maria Bogucka completed her studies at the University of Warsaw in 1951 and began working at the History Institute of the Polish Academy of Sciences (IH PAN), where she remained for more than half a century as head of the Department of Modern History. In the years 1951-1953 she stayed in Gdańsk, studying documents on the history of crafts. On the basis of written sources from the Gdańsk State Archive and under the surveillance of Prof. Marian Małowist in 1955 she presented her doctoral thesis under the title *Gdańskie Rzemiosło tekstylne od XIV do połowy XVII wieku / Gdańsk textile crafts from the fourteenth to the mid-seventeenth century*. In 1961 she completed her habilitation thesis concerning Gdańsk as a production center in the fourteenth to mid-seventeenth centuries. In 1970 she published a profound monograph on the history of the Foreign Trade of Gdańsk in the first half of the seventeenth century and in 1981 she received the title of full professor.

Professor M. Bogucka has devoted hundreds of articles to the history of Gdańsk, both scientific and popular. Especially noteworthy is her contribution as a co-author of the second volume of the monumental History of Gdańsk, edited by Edmund Cieślak in 1982. In 2007, for her great contribution to research on the past of Gdańsk, Maria Bogucka was awarded an honorary doctorate by the University of Gdańsk.

For Maria Bogucka, the history of Gdańsk was not the only direction of interest, but often a pretext to move on to the synthesis of the history of modern Poland and the history of Europe. The evolution of her interests is characteristic of many post-war scholars connected with or referring to the achievements of the French Annales school, i.e. a gradual transition from social history of economy, studied in long cross-sectional periods, to studies on everyday life, from the history of crafts and material culture to syntheses devoted to spiritual culture and gender studies.

Maria Bogucka did not start a family but put all her energies and talents at the disposal of Clio. She was an uncompromising person, for which she often paid with loneliness and even bitterness, visible in recent years.

Professor Bogucka's scholarly output is impressive and will certainly become the subject of separate historiographical studies, as will her role in building contacts between historians from different parts of the world, from the West and the East. For several decades, she represented Poland in the International Commission for the History of Towns (ICTH); furthermore, she was a member of the Polish Academy of Learning (PAU).

Maria Bogucka passed away, but she has bequeathed us a great, inspiring and lasting scientific heritage that will remain in our libraries forever.

DEREK KEENE (1942–2021)

Professor Derek Keene, who died on 17 April 2021 at the age of 78, was a major figure in European urban history. A strong supporter and member, from 1991, of the International Commission for the History of Towns, his interests focused on, but were not restricted to, medieval urban history, and he contributed to the development of many scholarly projects and initiatives. Since his death, tributes have circulated in various urban history networks. Friends and colleagues recall his energy, enthusiasm, engagement, generosity, and friendship; his willingness to discuss ideas and support new projects; the fact that he always had something fresh and valuable to contribute.

Derek was an enthusiastic historian and archaeologist from an early age. He read history at Oxford, and undertook a DPhil there on the urban development of Winchester. He was on the staff of the Winchester Research Unit (where he met his wife, Suzanne, then an archaeological conservator), from 1968 to 1978 (Assistant Director 1974–8). His magnum opus arising from this period was the magisterial *Survey of Medieval Winchester* (Winchester Studies, 2: 1985), complemented by several other publications including his contribution to the British Historic Towns Trust's *Atlas of Winchester* (2017), edited by his friend and colleague Martin Biddle.

In 1979 he moved to London with the first of a series of innovative research projects on London, based at the Institute of Historical Research but housed at the recently-established Museum of London. The Social and Economic Study of Medieval London applied the methodology of his research on Winchester to the much larger city of London, using the reconstruction of property histories as a tool to understand the material, social, and economic development of the city from the twelfth century to the Great Fire of 1666. The first project, focusing on the area of Cheapside, was followed by studies of Aldgate and Walbrook. Together these projects resulted in a substantial research archive as well as published outputs, and laid the groundwork on which later research projects could build.

In 1987 the Centre for Metropolitan History was established at the Institute of Historical Research, with Derek as its first Director: its success and reputation owed much to his distinction, and his ability to win substantial research funding. He was particularly good at thinking about how large and seemingly intractable questions could be addressed using an unconventional approach, and at putting this into practice in the projects he led. Important initiatives at the Centre included 'Feeding the City: London's impact on the agrarian economy of southern England, c.1250-1350', 'Metropolitan London in the 1690s', 'The growth of the skilled workforce in London 1500-1750', and several projects on markets and market networks. Of particular significance was his contribution as general editor to bringing to completion the massive history of St Paul's Cathedral: *St Paul's: the Cathedral Church of London, 604-2004* (2004). The Centre also attracted associate researchers and projects of high calibre, making it a centre of historical excellence and enterprise. In 2002 Derek was appointed Leverhulme Professor of Comparative Metropolitan History at the Institute of Historical Research, and was succeeded as Director of the Centre for Metropolitan History by Matthew Davies; he retired in 2008.

Throughout his career he served history, especially urban history, in a number of roles. These included Royal Commissioner on the Historical Monuments of England; member of the International Commission for the History of Towns; member of St Paul's Cathedral Fabric Advisory Committee; trustee of the *London Journal*; and member of the British Historic Towns Atlas Committee. He advised public bodies including the Council for British Archaeology, English Heritage, and the Arts and Humanities Research Council. He gave many conference papers, often subsequently published, and contributed essays to numerous publications, including the *Cambridge Urban History of Britain*, edited by Peter Clark (2000). Derek was a scholar of exceptional range and grasp. He bridged the disciplines of documentary history and practical archaeology, speaking the language of both, though his later career was more focused on history than archaeology; he extended his range from his first enthusiasm, medieval urban history, to consider aspects of 20th-century metropolises worldwide. He retained a wealth of knowledge from his wide and eclectic reading,

and this enabled him to make connections between topics and to recognise significant correlations or conjunctions. It is fitting that his final appointment was as Professor of Comparative Metropolitan History, since comparative history was his forte: the ability to draw insights from one topic or approach and apply them to another, to better understand and explore their relationship. His commitment to comparative history is exemplified in the essays he contributed to edited collections on capital cities, town and countryside, lords and towns, urban markets. He had a striking ability to look at a given fact or accepted interpretation – the ‘received wisdom’ we were all taking for granted - and perceive something different. He brought this penetration of thought and freshness of perspective to everything he tackled.

KARLHEINZ BLASCHKE (1927–2020)

Karlheinz Blaschke wurde am 4. Oktober 1927 im nordböhmischen Schönlinde geboren, er wuchs indes in Holzhausen bei Leipzig auf. Von 1946 bis 1950 studierte er Geschichte, Germanistik und Latinistik an der Universität Leipzig, wo er im Sommer 1950 mit einer Arbeit über die „Fünf neuen Universitätsdörfer (1543–1831)“ promoviert worden ist. Es schloss sich ein einjähriger Studienaufenthalt am Institut für Archivwissenschaft in Potsdam an. Von 1951 bis 1968 verrichtete Blaschke als wissenschaftlicher Archivar seinen Dienst am damaligen Landeshauptarchiv in Dresden (heute Sächsisches Hauptstaatsarchiv). 1962 habilitierte er sich an der Universität Leipzig, ohne dass ihm jedoch die *Venia Legendi* verliehen worden ist.

Zum 1. Januar 1969 wechselte er ans Theologische Seminar Leipzig (Mozartstraße), das sich damals in Trägerschaft der drei evangelisch-lutherischen Landeskirchen aus Sachsen, Thüringen und Mecklenburg befand. An dieser hochschulglichen, jedoch staatsfernen Bildungsstätte, in der beinahe ausschließlich Absolventen studiert haben, die in Opposition zur herrschenden DDR-Staatsideologie standen, entfaltete Blaschke als Dozent für Geschichte und Soziologie eine rege Lehr- und Forschungstätigkeit. Legendär waren nicht allein seine Vorlesungen und Seminare, sondern auch seine fortwährende Vortragstätigkeit in sächsischen Kirchengemeinden zur Landesgeschichte. Karlheinz Blaschke hat auf diese Weise eine Generation ostdeutscher Pfarrer, aber auch kritischer Laien, die zu seinen Vorträgen im Lande gepilgert sind, maßgeblich geprägt. Wer sächsischen Landesgeschichte in diesen Zeiten ideologiefrei hören, verstehen und begreifen wollte, musste zu Blaschke gehen. In diesen Jahren gab er die „Herbergen der Christenheit. Jahrbuch für deutsche Kirchengeschichte“ heraus (Bände 9–18). Zeitgleich fungierter er als Begründer und Herausgeber der „Quellen und Forschungen zur sächsischen Geschichte“ (Bände 1–9 [1963–1988]), ohne dass er im Impressum genannt wurde.

Im Zuge der Friedlichen Revolution und der wiedererlangten Einheit der Bundesrepublik wechselte Blaschke als Leiter des Referats für Archivwesen ins Sächsische Innenministerium über (1991/92). Von 1992 bis 1998 war er ordentlicher Universitätsprofessor für Sächsische Landesgeschichte an der TU Dresden. Maßgeblich hat Karlheinz Blaschke die sächsische Landesgeschichte nach 1990/92 grundlegend wieder neu aufbauen helfen. Er allein hat seit 1992 beharrlich und entschieden die Gründung des Instituts für sächsische Geschichte und Volkskunde – gegen die Widerstände von alten und neuen Kadern – vorangetrieben. Zeitgleich begründete er wieder als Herausgeber das „Neue Archiv für sächsische Geschichte“, das 1943 letztmalig erschienen war. Blaschke hat rund ein Dutzend wegweisender Darstellungen zur sächsischen Geschichte vorgelegt, darunter das Historische Ortsverzeichnis von Sachsen, die Bevölkerungsgeschichte Sachsens bis zur Industriellen Revolution, Sachsen im Zeitalter der Reformation, Geschichte Sachsens im Mittelalter, Beiträge zur Geschichte der Oberlausitz, den Atlas zur Geschichte und Landeskunde von Sachsen oder den Kursächsischen Ämteratlas 1790. Aufgrund seiner vielfältigen Verdienste wurde er – neben anderen Mitgliedschaften in Gelehrtengesellschaften – 1990 in die Historische Kommission bei der Bayerischen Akademie der Wissenschaften sowie 1991 in die Philologisch-historische Klasse der Sächsischen Akademie der Wissenschaften zu Leipzig kooptiert. Im Jahr 1997 hat man ihm mit der Sächsischen Verfassungsmedaille geehrte. 1999 erhielt Blaschke das Bundesverdienstkreuz 1. Klasse.

Karlheinz Blaschke ist am Vormittag des 25. Dezember 2020 im gesegneten Alter von 93 Jahren friedlich zuhause eingeschlafen. Bis zuletzt hat ihn seine Frau Renate, mit welcher er seit 1954 verheiratet war, herzlich und liebevoll versorgt und gepflegt.

JEAN-BERNARD MARQUETTE (1934–2020)

Nous avons le regret de vous informer du décès du professeur Jean-Bernard Marquette, survenu dans la nuit du 23 au 24 novembre 2020. Professeur émérite d'histoire médiévale de notre université depuis 2002, Jean-Bernard Marquette a consacré sa carrière à l'étude de l'Aquitaine et à la Gascogne médiévale, dont il était l'un des plus grands spécialistes, à l'enseignement, aux missions d'intérêt collectif ainsi qu'à l'investissement associatif.

Sa longue carrière professionnelle, commencée dans l'enseignement secondaire aussitôt après l'agrégation d'histoire (1957), s'est poursuivie à la Faculté des Lettres de Bordeaux à partir de 1967, puis à l'université Bordeaux III Michel de Montaigne, où il fut successivement assistant, maître-assistant, maître de conférences, puis professeur d'histoire du Moyen Âge et de sciences auxiliaires de l'histoire.

À la suite de Charles Higoumet (1911–1988), il a imprimé aux études médiévales des directions originales vers l'histoire de l'occupation du sol et du peuplement, les habitats fortifiés, les villes, la géographie historique et l'archéologie. Sa carrière scientifique est jalonnée de travaux marquants comme sa thèse *Les Albret*. L'ascension d'un lignage gascon (XI^e siècle, 1360, 1973), ses études sur les Landes de Gascogne et le Bazadais ou encore sur les vignobles (*De la vigne du pape au château du pape Clément*, 2018). Les projets ne manquaient pas : jusqu'à ces derniers jours, il travaillait à la prochaine publication des fouilles sur le site éponyme des Albret à Labrit.

Ses qualités de pédagogue, son érudition et sa grande connaissance des sources ont attiré vers les études médiévales plusieurs générations d'étudiant.e.s. À la suite de Charles Higoumet, il a dirigé la collection de l'*Atlas historique des villes de France*, à qui il a donné un véritable épanouissement éditorial (48 atlas publiés de 1981 à 2003), et a été membre la Commission Internationale pour l'Histoire des Villes à partir de 1988. Il a également assumé, dans le domaine scientifique, la codirection de la revue *Annales du Midi* (1989–2007), la direction du Centre de Recherches sur l'Occupation du Sol (1979–1990) qui, avec les centres Pierre-Paris et Georges-Radet ont formé l'actuel institut Ausonius (UMR 5607 CNRS-UBM), ainsi que de son laboratoire de cartographie historique. Il a été vice-président du conseil scientifique de l'université Bordeaux III (1990–1997) et directeur de l'Ecole doctorale histoire puis Histoire–Géographie (1991–1998).

Animé du souci de partager et de faire partager les connaissances sur l'histoire et le patrimoine de la région, Jean-Bernard Marquette s'est investi avec une passion communicative dans la vie associative ou aux côtés d'acteurs en charge de la valorisation du patrimoine: les Amis du Bazadais, association qu'il a fondée et dont il a pris la direction de la revue, *Les Cahiers du Bazadais* (1961–2014), les Amis du Musée d'Aquitaine (président), le Parc régional des Landes de Gascogne (vice-président du conseil scientifique), la Commission régionale du patrimoine historique, archéologique et ethnologique (COREPHAE). Jean-Bernard Marquette était membre résidant de l'Académie nationale des Sciences, Belles Lettres et arts de Bordeaux (2005), chevalier de la Légion d'honneur et officier des Palmes académiques.
